6. STAFF REPORTS

A. ADMINISTRATION

Scot Cuthbertson (Deputy Director, Department of Public Works) Substitute for Jim Reid (117 Fire)

- Mr. Cuthbertson confirmed that DPW is heavily engage in assisting fighting the 117 Fire and asked for some DPW staff to be excused, including Jim Reid and Troy Wiitala
- DPW implemented the Capital Lease Program, and fleet was able to purchase new equipment. Recently DPW received 8 new graders.
- New equipment allows highway crews to be safer and more efficient.

B. ENGINEERING/HIGHWAY DIVISION

Scott Cuthbertson (Deputy Director, Department of Public Works) Substitute for Troy Wiitala (117 Fire)

- Graveling Program: Completed Mid Jones Road, Baggett Road, Buckboard Drive, Forest Edge Road. 7.98 centerline miles have been completed to date.
- Stockpiling for Rush Road now.
- Nice weather helps the crews to stay ahead of the Graveling schedule for now.
- Graveling program will slow down because Dust Abatement and Chip Seal programs are about to start.
- Customer Service Requests: Drainage, Asphalt pothole patching, sign repairs and upgrades, Road grader maintenance.
- Snow Removal: DPW worked 5 snow/ice storms since February.
- DPW is busy with the Wildland fire support. Not counting this currently burning 117 Fire, DPW helped with 9 wildland fires this year.
- Highway Division currently posted 10 vacant positions for full time employees and 15 for summer seasonal employees.
- Graduation for Entry Level Workers will be on Thursday April 26th at 3:30pm at DPW Akers location.

C. ENGINEERING/HIGHWAY DIVISION

Jennifer Irvine (County Engineer, Department of Public Works)

- Mrs. Irvine informed all that Engineering Department is also closely involved with all the fires, mostly for damage assessments and future repair plans.
- Mrs. Irvine stated that DPW is re-doing traffic counts on Hodgen Road, due to some technical challenges (counts were not accurate).
- Mrs. Irvine presented and explained the 2018 Pikes Peak Transit Authority (PPRTA) maintenance budget and the 2018 PPRTA capital budget.
- Road and Bridge Funding (Federal Funding, usually in a form of Grants) was presented and explained. Each program has unique parameters and requirements.
- Mrs. Irvine explained the difference between Federal Gas Tax (HTF) and State Gas Tax (HUTF).
- In 2017 DPW accepted total of 7.21 centerline miles of roads.
- Mrs. Irvine presented aerial video of the West Colorado Avenue project and all updates.
- I-25 GAP Project update: CDOT is planning a Media release on April 27th and the Environmental assessment will be part of this briefing.

D. ENGINEERING/HIGHWAY DIVISION

Jennifer Irvine (County Engineer, Department of Public Works) HUTF – Highway User Tax Fund

- There are two major revenue streams to the HUTF. Major sources of revenue for the fund are: motor fuel taxes, vehicle registration fees, driver's license fees, traffic penalty assessments and oversize load permits.
- Funds are allocated based on a formula. Mrs. Irvine handed out the Allocation Methodology for HUTF to Counties and explained the process.
