# 6. STAFF REPORTS

#### A. ADMINISTRATION

# Scot Cuthbertson (Executive Director, Department of Public Works)

- Mr. Cuthbertson stated that DPW is constantly working on improving Chipping/Paving processes.
- PQI (Pavement Quality Index) data was received and is being processed. DPW is working with the County Administrator to create a format that is easy to use and understand.
- DPW currently has between 42-62 vacancies between three divisions. DPW partnered up with the Pikes Peak Workforce Center and is hosting a Job Fair on September 7 at the Akers facility. DPW started to promote this event.
- Snow Training Week for DPW is coming up in September, more details to share as they become available.
- EPC DPW recently did some improvements on Boone Rd. Mrs. Meinzer thanked DPW for the good work they did.
- EPC DPW truck wash is almost finished and should be running by Labor Day.
- Midway Ranch DPW helped putting up some signs and barricades, after heavy rains, on roads that DPW doesn't maintain.

#### **B. FLEET DIVISION UPDATE**

# **Scot Cuthbertson (Executive Director, Department of Public Works)**

- Mr. Reynolds (Fleet Manager) could not attend this meeting.
- Mr. Cuthbertson provided detailed list of the equipment purchased for the Reclamation Crew and other heavy equipment updates.
- EPC DPW also purchased some light duty vehicles. An average age on DPW's light fleet is 15+ years.
- ZONAR device is installed in all heavy equipment and some light vehicles.

# C. HIGHWAY DIVISION UPDATE

# Troy Wiitala (Highway Manager, Department of Public Works)

- Graveling Program:
  - Stock piled materials for Hahn Road
  - Prepping Pine Cone and east Coachman
- Dust Abatement Program: DPW is on schedule for 2019
- Chip Sealing Program: DPW completed 34.35 Centerline miles / 68.70 Lane miles.

- Mowing Program: DPW has 7 mowers working, this crew responds to a lot of customer service requests.
- Staffing/Manning: DPW is posting/interviewing vacant positions
- DPW is hiring seasonal employees for Fall Crack Sealing

# D. ENGINEERING DIVISION UPDATE

# **Jennifer Irvine (County Engineer, Department of Public Works)**

- Mrs. Irvine updated all on the speed limit signs on Marksheffel Road. EPC and City are still working together. EPC corrected the County's problem sections on Marksheffel Road.
- Mrs. Irvine explained with details the EPC MTCP (El Paso County Major Transportation Corridors Plan). This plan is used internally by DPW, PCD and CSD. - Project Highlights:

Colorado Avenue – coordinating ribbon cutting ceremony, tentatively in October Projects in Falcon (Park & Ride / Roundabout / US 24 New/Old Meridian Intersection) – DPW about to advertise in one package this fall Old Pueblo Road – finished wing walls, culvert and paving

- DPW is experiencing significant amount of service requests for drainage due to all the rains.
- DPW is monitoring a lot of intersections and bridges for improvements throughout the entire County.
- Engineering Department is almost fully staffed, last few remaining positions are advertised.
